96.50 (b) POST PLACEMENT/ADOPTION MONITORING COUNTRY SPECIFIC PROCEDURES

In the case of adoptions from **Armenia**, families will be required to submit reports at 3 months, 6 months, 12 months, 18 months, 2 years, 3 years, 4 years, and 5 years after the family arrives home. The first two reports must be completed by a social worker and the remainder of the reports is to be family generated and submitted to Hopscotch Adoptions, Inc. for approval. All reports will require 8-10 pictures of the child and the family submitted to the Post Placement/Adoption Coordinator or [Director of Clinical Services](#) at Hopscotch. The family will be sent reminders by the Post Placement/Adoption Coordinator or Director of Clinical Services when their reports are due. It is the family's sole responsibility to complete their reports and send them to Hopscotch in a timely manner. Once all reports have been received the family will be eligible to receive their post placement/adoption deposit refund. (Subject to change without notice)

In the case of adoptions from **Bulgaria**, families will be required to submit reports at 6 months, 12 months, 18 months, and 24 months, from the court date which finalizes the adoption in Bulgaria. The first FOUR reports must be completed by a social worker and submitted to Hopscotch Adoptions, Inc. for approval. All reports will require 8-10 pictures of the child and the family submitted to the Post Placement/Adoption Coordinator or [Director of Clinical Services](#) at Hopscotch. All reports must be apostilled and it is the family's sole responsibility to pay for the apostilling costs. The family will be sent reminders by the Post Placement/Adoption Coordinator or Director of Clinical Services when their reports are due. It is the family's sole responsibility to complete their reports and send them to Hopscotch in a timely manner. Once all reports have been received the family will be eligible to receive their post placement deposit refund. (Subject to change without notice)

In the case of adoptions from The **Republic of Georgia**, families will be required to submit reports at 3 months, 6 months, 12 months, 18 months, and 24 months after the family arrives home. After the 24 month report, the family is responsible for submitting family generated reports until the child is 18 years old. The first two reports must be completed by a social worker and the remainder of the reports is to be family generated and submitted to Hopscotch Adoptions, Inc. for approval. All reports will require 8-10 pictures of the child and the family submitted to the Post Placement/Adoption Coordinator or [Director of Clinical Services](#) at Hopscotch. All reports must be apostilled and it is the family's sole responsibility to pay for the apostilling costs. The family will be sent reminders by the Post Placement/Adoption Coordinator or Director of Clinical Services when their reports are due. It is the family's sole responsibility to complete their reports and send them to Hopscotch in a timely manner. Once all reports have been received the family will be eligible to receive their post placement deposit refund. (Subject to change without notice)

In the case of adoptions from **Ghana, Guyana, Morocco, Pakistan, Serbia and Ukraine** families will be required to submit reports at 3 months, 6 months, 12 months, 18 months, and 24 months after the family arrives home. The first two reports must be completed by a social worker and the remainder of the reports is to be family generated and submitted to Hopscotch Adoptions, Inc. for approval. All reports will require 8-10 pictures of the child and the family submitted to the Post Placement/Adoption Coordinator or [Director of Clinical Services](#) at Hopscotch. The family will be sent reminders by the Post Placement/Adoption Coordinator or Director of Clinical Services when their reports are due. It is the family's sole responsibility to complete their reports and send them to Hopscotch in a timely manner. Once all reports have been received the family will be eligible to receive their post placement/adoption deposit refund. (Subject to change without notice)
